In September 2021, Governor Gavin Newsom signed [AB 941](#) (Bennett, Chapter 203) into law, which established the Farmworker Resource Center Grant Program. This grant will make funding available to counties to establish and fund farmworker resource centers that provide information and access to services for farmworkers and their families.

The Department of Community Services and Development (CSD) will convene a meeting of the Farmworker Resource Center Workgroup to discuss and review the grantee program evaluation metrics and standards developed by the workgroup. Additionally, the workgroup will review the comments received at the public meeting held by CSD on August 18, 2022, and during the subsequent public comment period, which ended on August 26, 2022.
