## **AB 941**





### **Foundational Goal**

It is important for California to address the challenges faced by farmworkers and the agricultural industry. The department shall establish and administer a grant program for eligible counties to establish and fund farmworker resource centers that provide information and access to services for farmworkers and their families. (an excerpt from AB 941)





### The Need to Act

#### In California:

- Approximately 420,000 farmworkers
- Agriculture is both a major industry and employer.
- Farmworkers are an essential component of a successful and sustainable agricultural industry.
- It is important to address the unique challenges faced by farmworkers and the agricultural industry.
- California has long been a model for modern agriculture.
- Adapting to meet 21st century challenges and needs with broadly shared benefits for consumers, agricultural employers, and workers is essential.





## **Bill Overview**

- On September 22, 2021, AB 941 was signed into law.
- The budget appropriated \$3 million for administration of grants to support the establishment and funding of permanent farmworker assistance centers.
- Grants will be available to counties.
- Counties must provide 25% of the center's program funding.
- Farmworker Resource Centers may offer a broad array of services to address the numerous challenges and barriers that hinder the ability of the state's farmworkers to attain and maintain a decent quality of life.
- Services may be offered through traditional brick and mortar locations or mobile outreach.
- To the greatest extent possible, grants will be awarded to a geographically diverse group of counties to maximize access to programs.



## **Workgroup Composition**

### **REQUIRED by AB 941**

FRC Workgroup composition includes a representative from:

- An existing farmworker resource center (nonmanagement)
- CBOs serving the farmworker communities
- CBO working with indigenous farmworkers
- Labor and Workforce Development Agency
- A local public health department
- County Welfare Directors Association of California
- Farming community





## Role of Workgroup

In collaboration with CSD, the workgroup's purpose is:

- To develop and establish common indicators and metrics for the evaluation of grant applications,
- To develop standards and metrics for the evaluation of grantees postaward to ensure grant funds are used appropriately.

## Role of CSD

### CSD's responsibilities include the following:

- Convene and facilitate the FRC Workgroup
- Develop and oversee the release of the FRC grant Notice of Funding Availability (NOFA)
- Determine and approve awardees based on the standards and metrics that will be established in collaboration with the FRC Workgroup
- Ensure that grants are awarded to counties in different regions of the state
- Evaluate grantees using the standards and metrics that will be established in collaboration with FRC Workgroup
- Conduct evaluations within 18 months after grantees have established a center

- Applications submitted to CSD (October November 2022)
- Review and Evaluation Period
- Announce Awardees
- Issue Contract
- Conduct program evaluation

## PROGRAM FRAMEWORK



# **AB 941 Requirements**

- Grantees must work with local or statewide CBOs in order to develop the center.
- Grantees must provide 25% of center's program funding for the life of the grant.
- Center must provide services in English, Spanish, and other languages as requested by the relevant CBOs.
- Center must provide an assessment of the population it would serve which includes an assessment of the languages other than English or Spanish that would be accommodated by the center.
- Center must maintain a cost-effective database that can:
  - ✓ Track number and type of calls received,
  - ✓ Referrals made,
  - ✓ Claims filed,
  - ✓ Monitor local trends.
- Provide services through traditional brick and mortar locations or mobile outreach depending on local need.

- Providing resources and answering question regarding programs related to:
  - ✓ Labor and employment rights
  - ✓ Education
  - ✓ Housing
  - ✓ Utilities
  - ✓ Immigration
  - ✓ Health and human services (including food security, mental health, and childcare assistance)
- Assistance in filing paperwork with all state and local agencies that serve farmworkers
- Referrals to organizations, legislative offices, CBOs






