## **COMMENT PERIOD EXTENSION**

The Low Income Household Water Assistance Program (LIHWAP) provides financial assistance to low-income Californians to help manage their residential water utility costs. California was allocated \$116 million in one-time federal funding for LIHWAP under the Consolidated Appropriations Act of 2021 and the American Rescue Plan Act of 2021. The program is administered by the U.S. Department of Health and Human Services, and the California Department of Community Services and Development (CSD) has been the designated administering agency for LIHWAP in California since its launch in June of this year.

CSD is proposing to modify program eligibility to expand LIHWAP assistance to households seeking financial assistance for water and/or wastewater bills that do not have an arrearage and are current on their bill. Financial assistance for eligible households with current bills will be structured to ensure households with the lowest incomes receive the highest level of assistance.

CSD will hold a remote Public Meeting on November 29, 2022, at 1:00 p.m. to provide an overview of the updated LIHWAP Program Guidelines. A copy of the revised LIHWAP Program Guidelines is available at <a href="https://www.csd.ca.gov/Pages/LIHWAP.aspx">https://www.csd.ca.gov/Pages/LIHWAP.aspx</a>.
